Dear Mayor Davis:

On August 16, 2016 Governor Bentley executed the TAP agreement between the City of Graysville and Alabama Department of Transportation. The City of Graysville shall have no more than two (2) years from the date of the Governor's execution of said agreement to have the project authorized for construction. Please find attached the TAP agreement as reference.

On August 26, 2016, The Kelley Group entered into a contract with the City of Graysville to provide engineering design services for the Alabama Department of Transportation's Transportation Alternatives Program (TAP) grant for downtown streetscape improvements. Please find attached said contract (Task Order 2) as reference.

As of July 27, 2017, Task Order 2 between The Kelley Group and the City of Graysville is hereby cancelled. The Kelley Group is no longer the engineer of record for this project. The City of Graysville is free to consult with another engineering firm to complete the project pursuant to the existing TAP agreement with the State of Alabama and Alabama Department of Transportation.

Mayor Davis asked for authorization to consult with another engineering firm to complete TAP grant project.

Councilmember Hawthorne moved to authorize Mayor Davis to consult with another engineering firm to complete TAP grant project. Motion seconded by Councilmember Shaw and carried.

Mr. Tommy Greene, Comptroller was recognized and he stated the radio read water meters are now incorporated in our billing software, however the gas meters are still being read by physically getting out of the truck and going up to the meter. Mr. Greene stated the gas meters can be converted to radio read meters for about \$70 to \$80 each meter with in-house installation.

Mr. Greene asked permission to solicit bids to purchase 4700 strap on meters with anticipation of in-house installation.

Councilmember Teeter moved to allow Mr. Greene to solicit bids to purchase 4700 radio read strap on gas meters. Motion seconded by Councilmember Shaw and carried.

Mayor Davis presented contracts from JADE Consulting, LLC for civil engineering services and Terracon for geotechnical engineering services for tornado safe rooms #1 and #2.

Councilmember Shaw moved to authorize Mayor Davis to negotiate contracts from JADE Consulting, LLC and Terracon for engineering services for tornado safe rooms #1 and #2. Motion seconded by Councilmember Armstrong and carried.

Mayor Davis stated there were some bleachers that need to be declared as surplus.

Councilmember Shaw moved to surplus the worst bleachers and use the better bleachers at city parks. Motion seconded by Councilmember Hawthorne and carried.

Mayor Davis presented Ordinance Number 921 as follows:

## ORDINANCE NO. <u>921</u>

## AN ORDINANCE ASSENTING TO THE ANNEXATION OF CERTAIN

# PROPERTY OR TERRITORY TO THE CORPORATE LIMITS OF THE CITY SO AS TO ALTER, REARRANGE AND EXTEND THE CORPORATE LIMITS OF THE CITY OF GRAYSVILLE, ALABAMA – ALAWEST-AL, L.L.C.

WHEREAS, all of the owners of certain property or territory hereinafter described did sign and file a written petition with the City Clerk of the City of Graysville requesting that said herein described property or territory be annexed into the corporate limits of the City of Graysville; and

**WHEREAS,** the said petition filed with the City Clerk did include a legal description of said property or territory together with a map of said property or territory showing its relationship to the corporate limits of the City of Graysville; and

WHEREAS, said property or territory described in the petition referred to above has been warranted by all of the owners of the property or territory thereof to be contiguous to the corporate limits of the City of Graysville located in Jefferson County, Alabama, and does not lie within the corporate limits of any other municipality as shown by the map attached thereto; and

**WHEREAS,** the City Council for the City of Graysville has determined and found that the matters set forth and alleged in the petition referred to hereinabove are true, and that it is in the public interest that said property be annexed into the City of Graysville; and

**WHEREAS,** said petitioners did request in their petition that the City of Graysville adopt an ordinance assenting to such annexation and that the corporate limits of the City of Graysville be extended and rearranged so as to embrace and include said property or territory;

# **NOW, THEREFORE,** BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAYSVILLE, ALABAMA, AS FOLLOWS:

- 1. The foregoing Recitals are incorporated herein by reference as if copied herein in full and form an integral part of this Ordinance.
- 2. That said Council hereby assents to the annexation of said property or territory to the City of Graysville, Alabama.
- 3. That pursuant to the provisions of Subsection 11-42-20 *et seq.* of the <u>Code of</u> <u>Alabama</u> (1975), the following described property, to-wit:

See Exhibit "A" attached hereto and made a part of this Ordinance as If fully set out herein.

IS HEREBY ANNEXED TO THE CORPORATE LIMITS OF THE CITY OF GRAYSVILLE, and that said property or territory shall and hereby is, made a part of the City of Graysville.

- 4. That the above described property or territory is not within the corporate limits or police jurisdiction of another municipality and/or that the new corporate limits of the City of Graysville does not lie at any point more than one-half the distance between the old corporate limits of the City and the corporate limits of any other municipality.
- 5. Pursuant to Act No. 604, as amended, of the 1976 Legislature, the Petitioner does hereby agree that if the territory described in this petition or part thereof is in any fire district organized under the laws of the State of Alabama, an amount shall be paid to the fire district equal to six times the amount of dues that the owners of the territory being annexed paid to the fire district the preceding year, with said payment to be made by the owners; otherwise, as to the defaulting property owner, this petition/ordinance shall be null, void, and of no effect.
- 6. That the City Clerk of the City of Graysville Shall file a certified copy of this Ordinance in the Office of the Judge of Probate of Jefferson County, Alabama.
- 7. That a copy of this Ordinance be forwarded to the Tax Assessor for Jefferson County, Alabama and other appropriate federal and state departments or entities.
- 8. That there is excluded from the territory annexed pursuant to this Ordinance any portion of the territory described above which may be found to be the property of any other person, firm or corporation other than the petitioners or which may be found to lie in an area more than one-half the distance between the old corporate boundaries of the City of Graysville and the corporate boundaries of any other municipality and within an overlapping police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and the corporate boundaries of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of the City of Graysville and any police jurisdiction of any municipality.
- 9. That a copy of this Ordinance shall be published in a newspaper of general circulation in the City of Graysville.
