To rent the Graysville City Park Pavilions that are equipped with a stove, refrigerator, and food preparation area will require a fee of \$100. \$50 of the \$100 will be refunded after all categories of clean-up are completed from "Guidelines of Graysville City Park Pavilions' Renter".

GUIDELINES OF GRAYSVILLE CITY PARK PAVILIONS' RENTER

1. TIMEFRAME

All renters must give five (5) days' notice before the renter's event, **no exceptions**.

Community Volunteers (Park located) are used to enhanced park readiness and services (directed by the City of Graysville Park Manager).

2. PAYMENT OF FEE

Cash only. Secure name, address, telephone number and email.

3. CLEAN UP

Check out Sheet for Refund:

- a. All trash/debris should be contained in a construction garbage bag and placed in trash holder-can(s) if it is more than one (1) day before garbage pick-up.
- b. Clean restroom(s).
- c. All appliances and kitchen resources that were used should be left as found.
- d. All food should be removed from refrigerator, and refrigerator must be cleaned.
- e. No garbage should be left in kitchen area.
- f. Pick up all paper and trash from areas of Park that are used.
- g. Please check all clean-up categories.
