RESOLUTION NO 2019-5

RESOLUTION DECLARING AND DEEMING CERTAIN MUNICIPAL FIRE DEPARTMENT PROPERTY SURPLUS AND NOT NEEDED FOR PUBLIC PURPOSES AND AUTHORIZING AND APPROVING THE DISPOSAL THEREOF

WHEREAS, the City of Graysville, Alabama has certain items of fire equipment property which are no longer needed for public or municipal purposes;

WHEREAS, Section 11-43-56 of the Code of Alabama of 1975 authorizes the municipal governing body to dispose of unneeded personal property;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Graysville as follows:

SECTION 1. That the fire department property owned by the City of Graysville, which equipment is as follows:

- (4) Light Bars from emergency apparatus no longer serviceable
- (1) Box of incandescent equipment lights and parts for apparatus we no longer own

- (1) Oxi-Viva multi-patient 02 system obsolete equipment.

- (1) Life pack 10

SECTION 2. That the Mayor of the City of Graysville be hereby authorized and directed to dispose of the personal property of the City of Graysville, Alabama. The Mayor of the City of Graysville shall have the authority to reject all bids when, in their personal opinion, the bids are less than adequate consideration for the fire equipment property.

SECTION 3. That the Mayor and City Clerk be authorized to execute any and all contracts and or title transfer related to the disposal of the declared Surplus Property, the referenced in this Resolution.
