Resolution number 2019-6 was presented as follows:

RESOLUTION NO. 2019-6

WHEREAS, the City of Graysville, Alabama (the "City") has previously entered into an Abatement Agreement dated effective September 1, 2017 to induce Alawest-AL, L.L.C., Alawest, Inc., and Warrior Tractor & Equipment Company, Inc. (collectively, the "Developer") to locate, construct, equip, and own or lease a facility inside the city limits or police jurisdiction of the City; and

WHEREAS, the Project Development, Funding and Cooperation Agreement ("PDFCA") between the parties provided for a Substantial Completion Date of September 1, 2018; and

WHEREAS, the tax abatement Applications ("Applications") filed by Developer, which are incorporated by reference into the Abatement Agreement, provided for an estimated date of completion of December 31, 2018; and

WHEREAS, the Developer has requested an extension of the Substantial Completion Date in the PDFCA to March 31, 2019; and

WHEREAS, the Developer has requested an extension of the estimated date of completion for purposes of the Applications to August 31, 2019; and

WHEREAS, the City Council of the City of Graysville believes it to be in the best interest of the City to grant such extensions.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Graysville, Alabama, as follows:

1. That the Amendment to Abatement Agreement extending the estimated date of completion in the Applications until August 31, 2019 be approved; and

- 2. That the Substantial Completion Date in the PDFCA be extended until March 31, 2019; and
- 3. That Mayor Davis be instructed and authorized to execute the Amendment to Abatement Agreement and any other documentation required to effectuate the intent of this resolution.
- 4. That this resolution shall become effective immediately upon its adoption by the City Council of the City of Graysville, Alabama.
