RESOLUTION NO. 2021-3

BE IT RESOLVED by the City Council of the City of Graysville, Alabama as follows:

- 1. Longevity pay, pursuant to Resolution No. 2013-9, for fiscal year 2020 (beginning October 1, 2019 and ending September 30, 2020) shall be paid.
- 2. Resolution No. 2013-9 is hereby rescinded, effective September 30, 2020.
- 3. The City Council may vote to provide longevity pay ("longevity service years") for future years after September 30, 2020. In the event the City Council votes to provide longevity pay, the longevity year will begin on the first day of the City of Graysville, Alabama's fiscal year, October 1, and shall end on September 30 of the following year.
- 4. Time of service for purposes of longevity pay shall be measured from the beginning date of full-time employment through September 30 of the fiscal year, and will be based on full years of uninterrupted service. Fractional years shall be disregarded.
- 5. In the event the City Council votes to provide longevity pay for a fiscal year, the City Council will determine the total amount to be allocated to such pay. Only full-time employees with two (2) full years or more of uninterrupted full-time employment service with the City of Graysville, Alabama shall be eligible for longevity pay.
- 6. Leaves of absence approved by the City Council shall not be construed as an interruption of time. Absences without leave, lay-offs, and suspensions without pay will not be considered in computing total longevity time.
- 7. Any employee otherwise eligible for longevity pay who is dismissed for cause at any time prior to payment shall not be entitled to said longevity payment.
- 8. In the event the City Council votes to provide longevity pay for a fiscal year, the City shall utilize the following to calculate the pay to each eligible employee:
- (a) A calculation will be made as to the number of years of uninterrupted service for each eligible employee with two (2) years or more of full-time uninterrupted service at the end of the fiscal year;
- (b) The number of collective years of eligible full-time service for all employees shall be totaled;
- (c) The total amount allocated by the City Council to longevity pay shall be divided by the total number of years of service of eligible employees to establish a value for each year of service; and
- (d) Each employee will then be paid the value per year times the number of his or her longevity service years.

9. The City Council shall be the final arbiter of any dispute as to the employee's eligibility or number of years of service. 10. Nothing contained within this resolution shall create or be construed as any right or entitlement to future longevity pay. 11. If any part, section or subdivision of this resolution shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this resolution, which shall continue in full force and effect notwithstanding such holding. 12. Be it Ordained by the City Council of the City of Graysville, Alabama, as follows:

Section I

The Mayor of the City of Graysville is to act as Superintendent of the Graysville Municipal Gas System and as such shall serve as purchasing agent for such system, make all purchases authorized by the City Council therefor, keep a check on meter readings and billings for service of the system and see that the collections thereof are made. He shall see that the system is kept in proper repair and operation, shall keep an inventory showing the supplies and equipment on hand for such system, shall keep a full and complete monthly financial statement of all operating costs and receipts and keep a proper inventory of the physical assets of such system. He shall further handle all such data and information relative to such system available for the City Council at such times at it shall require, but not less frequently than once every three months.

Section II

For his service as Superintendent of such system, the Mayor shall be paid, in addition to his salary as Mayor, a sum of \$3,568.95 per month plus any benefits available to full-time employees of the City of Graysville, which the City Council deems as a reasonable sum. The City Council may, at any time it deems best, dispense with the Mayor's service as Superintendent.
