Dear Graysville Town Council

My letter is to be read into the next official Graysville Town Council public meeting, and made an official part of the minutes.

I'm asking for help in correcting hazardous & property devaluing conditions next door to me at 3944 Cherry Avenue, Birmingham AL 35214. The current owners in the past were served condemnation papers but the property wasn't condemned. The hazards have worsened since they weren't condemned.

We have had nothing but problem since the current owners took over the property. For the most part the house has been vacant since 2017. Cars are parked in the yard to make it appear someone lives in the house. The property is being used to dump junk including old beer cans thrown off the back porch in 2017 that are collecting rainwater and mosquitoes.

Due to the junk in the yard (including but not limited to an abandoned toilet, bathtub, tires and other junk) we have to fight on a regular basis an onslaught of mosquitoes, roaches, rats and snakes coming from 3944 Cherry Avenue. We didn't have these pests coming over until these people took ownership.

There was a fire at the house under the previous owner and another is just waiting to happen with all the junk and chemicals stored there.

These people have allowed their trees and kudzu to overgrow our fence and scrape against the side of our house. The leaves that fall from their overgrown trees have rotted our deck. The herbicides they've used have caused my asthma to worsen. It's also killed the grass in our yard.

Now they've started parking their cars around the parking awning which is so full of junk no cars can be parked there. They're parking their cars so close to the road that on-coming traffic is going to hit them. When that happens, they're parking right on our fence and that's going to cause them to knock down our fence.

Unless the City of Graysville permanently addresses these issues with the current owner, and forces them to clean up all the junk, chemicals, and overgrowth these unhealthy and hazardous conditions will continue to the detriment of both our health and property value.

We will hold the City of Graysville accountable for not rectifying these health and property hazards once and for all.

Councilmember Teeter presented the Graysville Fire report for the month of January, 2023 due to the absence of Fire Chief Greg Gilchrist.

Mayor Davis presented the Graysville Police report for the month of January, 2023 in the absence of Police Chief Ken Marbury.

Councilmember Hawthorne said she would like to discuss the resolution mentioned at the last meeting in reference to closing out the cooperation agreement with Jefferson County on the Graysville SE park project.

City Attorney, Charlie Waldrep explained the resolution and stated if the council will approve the resolution this would allow the City to terminate and close out the cooperative agreement and authorize Mayor Davis to execute any and all documents from Jefferson County to the City to terminate cooperative agreement.
